## **Basic Death Investigation Course**

POST Control # 2060-31200-24-001

The Basic Death Investigation Course is designed to develop the knowledge and skills of newly hired Deputy Coroner and Medical Examiner Investigators, and all Deputy Sheriff Personnel with Coroner responsibilities. The full course provides 80 hours of education in Role of the Death Investigator, Death Notification, Infant Death Investigation, Public Administrator, report Writing, Coroner Laws, Basic Human Anatomy, Time of Death, Pathology, Disaster Management, Media Relations, Psychological Autopsy and Profiling, Critical Incident Stress Management, Fire Death & Explosives, Asphyxial Deaths, Unusual Forensic Cases, Toxicology, Firearms, Forensic Dentistry, Forensic Anthropology, Blood Stain Pattern Interpretation and Courtroom Testimony.

California POST requires Peace Officer Death Investigators who fall under CA Penal Code Section 830.35(c) to complete these 80 hours of training within the first 12 months of their date of appointment. Peace Officer Death Investigators who fall under CA Penal Code Section 830.1 are strongly encouraged to complete this course.

LAPTOP AND PROPERLY FITTED PPE MASK ARE REQUIRED FOR THIS COURSE.
